It is an honor to represent Maine in the United States Senate, and I welcome this opportunity to share several key accomplishments for our state from the previous year.

As Vice Chair of the Appropriations Committee, I have secured nearly \$580 million for 230 projects across all of Maine's 16 counties to promote job creation, workforce training, and economic development; and access to health care; support law enforcement; improve public education and infrastructure; and protect environment. As the new Congress begins, I am honored to be taking the helm of the Committee, the first woman to do so in nearly a century, and I remain committed to ensuring that federal spending produces real results for our state and nation.

Maine has the oldest average age in the country, which is why I have long prioritized health-focused legislative efforts. There were more than 1,860 health care bills introduced during the 118th Congress. Only 15 health care bills were signed into law, and I was a lead sponsor of five of them. These bills will enhance care for individuals with Alzheimer's, autism, and substance abuse issues through improved research funding, strengthened public health programs, and increased support for rural first responders.

Another important bill that I coauthored was the *Social Security Fairness Act*. Since 2003, when I led the first-ever Senate hearing on the Windfall Elimination Provision and the Government Pension Offset, I have fought to end these provisions of the *Social Security Act* that unfairly reduce the Social Security benefits that public employees or their spouses have earned. I am pleased to say that with the passage of my bill, the *Social Security Fairness Act*, in December, public sector retirees will now receive the full Social Security benefits they earned.

When the Maine way of life was under threat, I was certain to defend the interests of our state. I worked to protect Maine's potato farmers when the Department of Agriculture tried to reclassify the potato from a vegetable to a grain. I thwarted efforts to consolidate USPS mail operations at the Hampden postal facility, which would have disrupted mail delivery throughout our state. I sounded the alarm with leaders at the FBI and Departments of State and Treasury on the spate of illicit marijuana growing operations that are destroying properties and providing refuge to foreign criminals in our state. Following damage to our working waterfronts from last winter's storms, I secured \$15 million to help fishing communities recover. I championed funding to support the Maine Air National Guard base, Bath Iron Works, and Portsmouth Naval Shipyard.

As of last December, I have cast more than 9,100 consecutive votes, continuing my record of never missing a roll-call vote since my Senate service began in 1997. My ranking as the most bipartisan Senator reflects Maine's tradition of working with a spirit of cooperation and respect.



Dear Friends,

I hope this letter finds you well. It's an honor to continue serving as your representative in Congress, and I take the responsibility very seriously. Thank you for the opportunity to share an update on the work I've been doing for the people of the Second Congressional District.

Fisheries: This spring, the Atlantic States Marine Fisheries Commission (ASMFC) announced a gauge increase for lobsters caught in the Gulf of Maine beginning in January 2025. Maine fishermen warned that this decision is founded on incomplete and inaccurate data. Additionally, this gauge increase could put Mainers at a competitive disadvantage to Canadian fishermen with looser regulations. That's why I sent a [letter](#) to the ASMFC urging them to delay their decision until they can evaluate data with fishermen, whose proactive stewardship provides invaluable insight. I have also submitted an amendment to this year's funding bill that would block federal funding from being used to implement and enforce a gauge increase. Because of these efforts, the ASFMC made the decision to delay the implementation of this new requirement. I'll always stand with Maine lobstermen against unfair, unnecessary regulations that threaten their livelihoods and industry.

Veterans: The first meeting I attended as an elected official was with a large group of veterans and the former Director of the Maine Bureau of Veterans Services. We discussed a lot, but one issue rose above the rest: how little was being done for Maine veterans who needed treatment for mental health issues or substance use. At the time, there were no in-patient treatment beds in Maine, so veterans had to wait for a bed to open up at an out-of-state facility. Fast forward 10 years, through unending red tape, and I'm delighted to report we just broke ground on a treatment facility at the Togus VA Medical Center in Augusta. This was the direct result of the tireless advocacy of veterans from across our state — this win is theirs.

Postal Service: This spring, the U.S. Postal Service (USPS) announced plans to consolidate and move some processing operations from the Eastern Maine Processing & Distribution Center in Hampden to Scarborough. This would have caused significant mail delivery delays that disproportionately harm rural communities. That's why I introduced the *Timely Mail Delivery*

Dear friends and neighbors in my hometown of Town of New Sharon,

The Sheriff's Office answered 2,134 calls for service in the Town of New Sharon in 2024 which is 241 calls higher than the previous year. In 2023 we covered 1,893 calls for service.

Whether or not calls for service increase or remain stable, we have seen an increased demand for patrol to assist towns who may have police departments that find it difficult to fill vital patrol slots. The Sheriff's Office Patrol Division remains a force multiplier to assist those towns. We have either covered calls full-time in some towns or assisted in filling a patrol gap when needed. We will always do our best to support our patrol friends and peers in all towns within the county.

Because of these increased needs, we have had to find innovative ways to add additional staff through grants or the state Unorganized Township funds to fill our own gaps in coverage. We have also added an additional sergeant's position to our supervisory staff to help oversee patrol operations day.

We continue to see an increase in people who are drug addicted or suffer from mental health issues. Whenever a deputy runs into this type of contact it can easily take him off the road for hours if not for the rest of the patrol shift while he guides the person in crisis through the process of seeking the help they need for their addiction or mental health issues.

Where do people go after they have had contact with law enforcement and have been arrested? Well, they go to the county jail. Our dedicated staff of Corrections Officers work hard within the walls of the jail to also help guide people who arrive angry and/or addicted.

In order to help combat these issues within our community, the Sheriff's Office through the leadership of Franklin County S.O. Sergeant Ryan Close and Director LeeAnna Lavoie of the Healthy Community Coalition of Franklin County applied for and received a Bureau of Justice Assistance grant called COSSUP. This stands for "Comprehensive Opioid, Stimulant and Substance Use Program". This grant will enable the Sheriff's Office Jail staff to comprehensively address the impact of illicit opioids, stimulants, and other substances through a vetted model approach which has proven results in other jails within Maine. This model, once fully implemented, will work to prevent and reduce drug overdose incidents and death, as well as reduce jail recidivism rates.

Not only have we been working on behalf of people that encounter law enforcement, but we have also been concerned with the mental health of our local first responders within Franklin County. In March of 2023, several public safety agencies within Franklin County banded together to create the County's first Public Safety Peer Support Team. Working with the International Critical Incident Stress Foundation (ICISF), all members of the team were trained and certified in Critical Incident Stress Management (CISM) in April of 2023.


The Franklin County Peer Support Team provides several services for First Responders in Franklin County. These first responders include fire, EMS, corrections and patrol personnel. Primarily, members are resources for their agencies and those surrounding them. Members organize and facilitate Critical Incident Stress Management Debriefings when requested. In 2024, members organized and facilitated 7 Debriefings with over 90 participants. Members also conduct one on one check ins when a referral for a First Responder was received. Members organized and facilitated dozens of one-on-one check ins.

The Franklin County Peer Support Team has continued to add members to the team and get them CISM trained. The FCPST meets monthly to discuss various topics, trends, and continue on-going training to keep skills fresh. This allows the team to be ready to respond at any time. In September, the area hosted its annual Wellness and Resiliency Seminar at UMF which was widely attended by over 90 First Responders locally and from away.

In closing, I want to thank all of you for the support that you have provided to the Sheriff’s Office over the years. We could not be as successful as we have been without you as our partner. 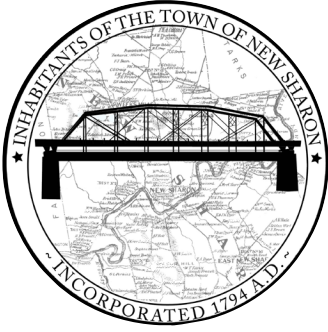

REPORT OF THE SELECTMEN



The 2024 calendar year presented the Selectboard with numerous challenges. Following the significant flooding and road damage experienced in late 2023, Selectman Pond actively participated in weekly meetings with Road Commissioner Pond and Federal Emergency Management Agency (FEMA) officials. These meetings were crucial for data collection and the submission of reimbursement claims for road repairs.

In March, the Board welcomed Kathleen “Katie” Reis as the newest member, succeeding Travis Pond. The Board extends its sincere gratitude to Travis for his years of dedicated service and valuable contributions. His expertise and support during the transition was very helpful.

The Board appointed Robert Ayer as the new Animal Control Officer in March. He got started right away caring for all the animal needs in New Sharon, and continues to be very responsive to calls from residents.

Following a competitive bidding process in April and again in June, Abbott’s Lawn Care & More was awarded the town’s mowing contract for 2024, and the Board awarded a 3-year winter plowing contract to Josh Meader. The Board expresses its sincere appreciation to E.J. Pond & Sons and their dedicated plow crew for their many years of exceptional service to the Town.

In June, the Selectboard hosted a four-day cemetery conservation workshop led by Professional Conservator Joe Ferrannini, made possible by a grant from the Maine Old Cemetery Association (MOCA). The New Sharon Masonic Lodge donated space for the group to initially meet on Friday and enjoy breakfast from Root Down Market, before the Twenty-five participants began working to reset/repair 20 headstones and cleaned approximately 110 stones at the New Sharon Village Cemetery. Despite challenging weather conditions throughout the weekend, the workshop was a resounding success, and the improved appearance of the headstones is a testament to the hard work and dedication of all involved.

Over the summer we were informed by the Department of Transportation that the Bullens Mills Bridge was no longer safe for regular passage of school buses, fire trucks, and other regular heavy traffic. Wentworth Partners & Associates, the engineering firm, oversaw the bidding process, which received five visitors to the site and two bids. The Board awarded the contract to Wyman & Simpson, the low bidder at \$744,000. Following approval at a special town meeting, the project was funded through the Maine Municipal Bond Bank at a rate of 2.86 for a term of ten years. Construction commenced on September 3rd and was successfully completed ahead of schedule on November 13th.

The Selectboard seated the New Sharon Water District Board of Trustees three times throughout the year. The Board attended countless meeting with the PUC regarding the viability and survivability of the Charter. The Selectboard also attended an in-person meeting at Cape Cod Hill School fielding many questions and concerns of residents. Many meetings with the PUC, Maine Rural Water and the Advocacy staff were attended to help with the financials and direction of the New Sharon Water District. After the Board seated the Trustee Board for a third time, a partnership was then established between Maine Rural Water and the water district.

In November the Board approved the replacement of several obsolete computers at the town office. These upgrades were necessary due to equipment failures and the absence of significant computer updates since 2016 for most in the office.

The town-wide Reval conducted by KRT Appraisal faced several unforeseen delays. As a result, the Board was unable to finalize the tax commitment until November 8th, causing a delay in the mailing of tax bills. However, the completed revaluation yielded positive outcomes: a reduction in the municipal tax rate from 17.5 in 2023 to 10.9 in 2024, and the eligibility of qualified residents for the full Homestead exemption. Additionally, the town will continue to receive various State revenues at full value that will help to reduce taxation. Due to the significant delays experienced during the revaluation process, the Board successfully negotiated a \$7,000 reduction in its final payment to KRT Appraisal. The original contract was for \$137,000.



REPORT OF THE SELECTMEN

In December, Selectman Kevin Libby submitted his resignation, effective March 2025. This resignation will create a one-year vacancy on the Board due to his upcoming military deployment.

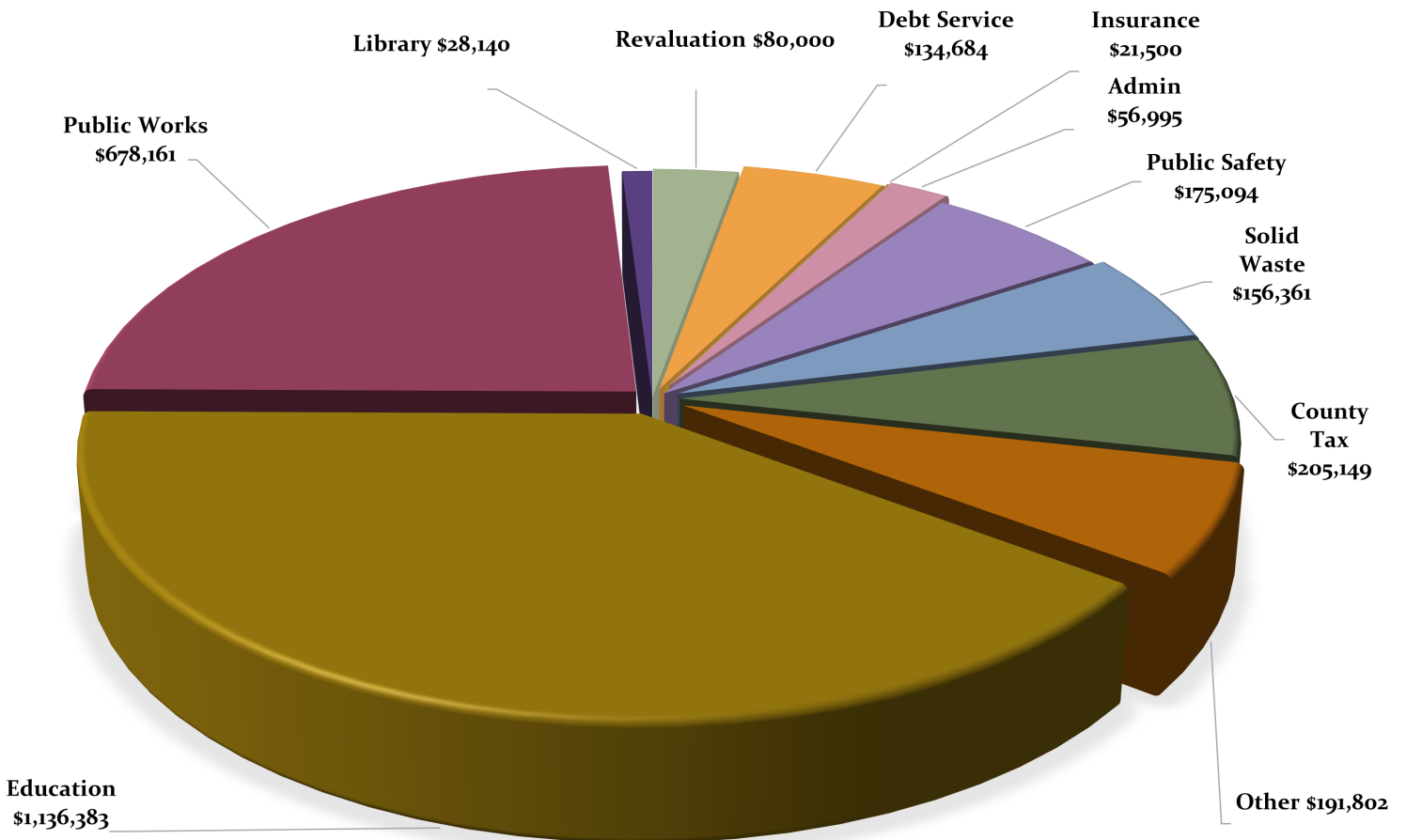

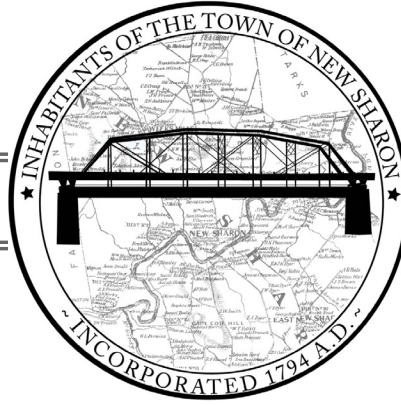

From the Treasurer's Desk

Greetings New Sharon!

I'm excited to update you on the Town's finances and some important projects that have been underway.

In early January of this year, we met to begin the process of creating the budget and warrant for the annual Town Meeting. I was excited to see a few new faces at our early Saturday morning budget meeting. We understand the importance of fiscal responsibility and are always working diligently to keep costs as low as possible while still maintaining the essential services the community relies on. We know that every dollar counts, and we are committed to using your tax dollars wisely. I love it when residents join us for financial planning!

I am pleased to report that we received our first reimbursement from FEMA in late December for expenses related to the declared storms we all remember. We received a second reimbursement in early February 2025. The total for the two installments is \$169,846.50. These funds will be instrumental in completing necessary road repairs and improvements throughout town in 2025. We appreciate all the effort John Pond has put into working with the federal government to secure these reimbursements for the Town.

In other infrastructure news, we successfully secured a loan of \$744,000 to replace the Bullens Mills Bridge on the Crystal Vale Road. We were able to secure an interest rate of 2.86% for a term of ten years. It was an unexpected project for 2024, but the bridge was no longer meeting industry standards and had to be closed to traffic. The new bridge was completed and passable just before the end of the year.

As many of you are aware, we finalized the town-wide revaluation last fall. This project was a huge undertaking for the town and spanned two years. Significant delays due to unforeseen IT issues and an extension requested by KRT, forced us to commit taxes much later than usual. The board continued to push back the commitment until they felt that your values were fair and accurate for the 2024 tax commitment. In the end, the Select Board successfully negotiated a reduction in the final payment by \$7,000. We are very pleased to have this important project behind us.

On a personal note, I took advantage of a few refresher training opportunities last year and am excited to continue learning and growing in my role in 2025. My position and the level of responsibility have increased exponentially since I began serving as your Treasurer, and I am dedicated to staying up-to-date on best practices in municipal finance.

Finally, I want to express my sincere gratitude to the residents of New Sharon for your continued support. I also want to thank Pam, Myrna, the Select Board, and all the other town employees for their hard work, collaboration, and dedication to the residents of New Sharon. It is a privilege to work alongside all of them.

Greetings New Sharon residents,

I would like to thank you for the opportunity to be your Animal Control Officer. There was a bit of a learning curve at the beginning, but I hope I have been able to respond to your questions, concerns and situations in a timely and professional manner. It has been my pleasure to serve New Sharon. Between March 19th and December 31st, I responded to 119 calls and logged 1726 miles in the performance of my duties. Averaging 14.5 miles per call. As well as answering several dozen calls from residents with concerns, questions or in need of information.

I encountered a wide variety of animals and circumstances. From bats to llamas and just about everything in between. To say the least, it has been interesting, no two calls are the same. Many calls were about cats. Stray, Feral, Wild, Injured, Sickly, Abandoned, Nuisance cats and kittens. If you feed a cat, please take responsibility for that animal and get it spayed or neutered before the inevitable problem arises. The Franklin County Animal shelter has programs in place to help you with this process.

Keep your dog's out of the road and off your neighbor's property. Keep them away from other pets, livestock, people and children unless specifically given permission. There is a leash law. Remember to license each dog at the Town Office and bring proof of a current rabies vaccination. No one wants to deal with the state mandated fine for not registering a dog.

Additionally, we began upgrading essential equipment, including replacing outdated Self-Contained Breathing Apparatus (SCBA) certified to 2002 NFPA standards. The new units, certified to the 2018 NFPA standard, enhance safety and reliability. To manage costs, we plan to purchase two SCBA units annually, ensuring compliance with NFPA standards while maintaining fiscal responsibility.

For those interested in becoming part of our dynamic team, we extend an invitation to attend our business meetings on the 1st Monday of the month at 6 pm, training sessions on the 3rd Monday of the month at 6 pm, or truck checks every Sunday at 8 am. We also have openings in our Junior Firefighter program for high schoolers aged 16 and 17 who aspire to serve in the fire service.

In closing, I express sincere gratitude to all members of the department for their unwavering professionalism and dedication to both the department and the residents of New Sharon. Your collective efforts have been instrumental in ensuring the safety and well-being of our community.

ROAD COMMISSIONER

April 8th, we had a FEMA hazard mitigation team respond to the George Thomas Road to check out the slide that had been started, on April 12th it turned into a major washout. Reconstruction of the side of the road, and culvert replacement was completed.

I Met with FEMA representatives every Wednesday from January through August for 3 hours each time to complete necessary paperwork for natural disaster reimbursement(s) for the Dec. 2022, May 2023, Dec. 2023 storm damages.

Lane Road: Ditching, and cross culvert replacements in preparation for a mile of hot top was applied. Hot top was also applied to washout areas on Smith Road, aprons on Glenn Harris and Dyer Brown Roads, also the entrance to Main Street. Bridge on Muddy Brook Road required a specialized team of divers to come in and provide a cement-based stabilization under the bridge. The Lane Road bridge was stabilized by applying granite blocks to the wing walls. The bridge on Crystal Vale Road was replaced after failing engineer reports were received from the state.

Gravel and ditching were done to various roads and grading was done as needed.

Both the Holman House and the Bjorn Center projects were accomplished through grant funding.

As part of the RSU 9 Strategic Plan, the District is making improvements to the teaching of reading while also focusing on classroom instructional interventions for students who may struggle while also looking at ways to help students increase their engagement in class. Foster Tech Center reintroduced an electrical program for those students looking to pursue a career in the electrical field.

Challenges that the district has faced.

- Dry pipe sprinkler system at Middle School had a leak during the Summer that caused extensive damage to the gym floor and the basement area below. While this damage was covered by insurance the dry pipe system is at/passed its life expectancy and will need to be addressed in the future to prevent similar events from happening
- Cape Cod Hill School's leach field is failing and is set to be replaced late Winter/Spring 2025

RSU 9 current enrollment as of 12/31/2024 is 2279 students. 13 graduates were from New Sharon out of 168 in 2024.

**WATER DISTRICT
BOARD OF TRUSTEES**

As many of New Sharon residents are aware, the Water District has had a busy and productive last few months. There have been several developments regarding the Water District that have improved the short- and long-term viability of the system. These changes occurred after and in part in response to the Maine Public Utilities Commission Hearing on May 2, 2024. Since that time the Water District Board was reconstituted by the following trustees:

- Shanelle Lake has become the chairperson and

has been dynamic in getting the Water District on a solid financial and technical foundation.

- Jim Reis has been the scribe and meter reader and has worked tirelessly to take care of many of the day-to-day issues that water systems encounter.

- Jeff Brackett, Del Harris, and Ed Ferreira have served as trustees.

- Mark Deden has continued to serve with resolve and competence as the district's operator.

The Water District has contracted with Maine Rural Water Association to conduct its billing and customer service.

There has been a 64% rate increase to water users to bring the district to a sustainable level of financial solvency and regulatory compliance.

There have been numerous initiatives that bear mention. The district has worked on a lead service inventory required by the Federal government to ensure there are no lead pipes in the system.

The district has worked collaboratively with the New Sharon Fire Department and their chief, Felicia Bell, to flush and inspect the fire hydrants in New Sharon. This collaboration between the Water District and the town, through the Fire Department, helps keep homeowners' insurance rates as low as possible.

The Water District has also upgraded their telemetry capability to keep track of water levels in the district's underground storage reservoir so that it can advise the Fire Department of water levels during a firefighting emergency.

Through the excellent efforts of Board Chairperson Lake, the Water District has recently been awarded an ARPA grant through the Franklin County Commissioners for approximately \$50,000. The plan is to use these grant funds to purchase generators that will enable the Water District to provide water to the hydrants and businesses, and residences on the system in the event of prolonged electricity outages. As was said earlier, these initiatives have improved the viability and sustainability of New Sharon's Water District. The Water District would like to thank the town's select people for the collaborative reports that have strengthened this service's ability to provide safe and high-quality water to both businesses, residences and the town's Fire Department.
